## STEPHEN HOPKINS OF THE MAYFLOWER\*

## AND SOME OF HIS DESCENDANTS

1. Stephen Hopkins, born in England in 15—, died in Plymouth, Mass., between 16 June and 27 July 1644. He married first—, who died in England; and secondly, in February 1617, Elizabeth Fisher. This second marriage may have taken place in the parish of St. Mary's, Whitechapel, London, England, but this is not probable. It is known that he was married the second time in England and that his second wife came to Plymouth with him and died there before her husband. (The New England Historical \*\* AND Genealogical Register, vol. 33, p. 300, asserts that he came to America on a former expedition.) Governor Bradford says, "They lived about 20 yrs. in this place".

An extended account of Stephen<sup>1</sup> and some account of the descendants of his grandson Joshua, written by Josiah Paine of Harwich, Massachusetts, was published in 1913 as #63 of the Library of Cape Cod History and Genealogy. "The Doty-Doten Family in America", by Ethan Allen Doty, 1897, p. 8, states that Stephen

Hopkins was a tanner or leather maker.

Stephen Hopkins came over in the Mayflower with his wife Elizabeth and one child by her and two children by his first wife. He was a prominent man in the colony, and the details of his

service are published in many places.

Captain Miles Standish and Mr. William Bradford deposed to his will 20 Aug. 1644, and his son Caleb was made executor. This and a full history of his records will be found in the booklet of Mr. James W. Hawes published by the Yarmouth Register in 1915 and

in a similar booklet by Josiah Paine of Harwich.

His will was dated 6 June 1644 and proved 20 Aug. 1644. In it he mentions his deceased wife Elizabeth; his sons Giles and Caleb; his daughters Constance Snow, Deborah, Damaris, Ruth, and Elizabeth; and his grandson Stephen, son of Giles. His son Caleb was named executor. A copy of the will may be found in The New England Historical and Genealogical Register, vol. 4, p. 281.

<sup>\*</sup>I have no reason to believe that John! Hopkins of Hartford was related to Stephen! of the Mayflower. I have seen statements that he was the son of Stephen; but as Stephen does not mention him in his will, and Bradford makes no reference to such a son of Stephen, and no one has found any authority which is based upon any fact. I do not think that any faith can be placed in such statements. (Letter of T. H., 28 April 1908.)

Children by first wife:

Constance, sometimes written Constanta, b. in England ca. 1605; d. in 1670. (Note to Freeman's Cape Cod states that she d. in d. in 10/0. (Note to Preeman's Cape Cod states that she d. in 1677.) It seems almost positive that she could not have been under 12 years of age when the *Mayflower* landed in 1620, and she was probably 15. She m. prior to 1628 Nicholas Snow, who came in the *Ann* in 1623. Governor Bradford says, probably about 1650, "Constanta is also married and hath 12 children, all of them living, and one of them married". There is no positive record of all of their shidren has the following and positive record of all of their children, but the following are known.

2. GILES<sup>2</sup> HOPKINS (Stephen<sup>1</sup>), born in England ca. 1607, died in Eastham, an octogenarian, in 1689 or before 26 April 1690. He married in Yarmouth, 9 Oct. 1639, CATHERINE WHELDEN, died in Eastham after 15 March 1689, daughter of Gabriel Whelden of Yarmouth. See Pope's "Pioneers of Massachusetts", p. 489, for a letter from Catherine Whelden to John Shanvat, dated 1639.

He lived for a time in Plymouth but about 1638 moved to Yarmouth. He was highway surveyor of Yarmouth (Mattakeese), 1642-43, and surveyor of Yarmouth and Eastham (Nauset) until 1662. He was among the first settlers of Eastham 22 May 1655 and in 1655 he was one of the list of freemen of Eastham and one of twenty-nine voters there.

His will, dated 19 Jan. 1682, proved 5 March 1689, mentions his wife Catherine and his sons Stephen, William, Caleb, and Joshua. His son Stephen was made executor.

Of the following children, the first four are believed to have been born in Yarmouth, the remainder in Eastham. Their names are on record in Orleans.
